Initial FOLLOWING:

- _____ 1. Applicant(s) must be 21 years of age or older. Permit application is not transferable. Applicant(s) and any User(s) are not part of a paid or commercial tour / group.
- _____ 2. User is permitted the non-exclusive use of Hukilau Campgrounds, Hukilau Picnic Area, or Po'ohaili Campgrounds (the "Property") as described below. **User is responsible to see that the Property is cleaned and everything removed between scheduled uses.** No EZ-corners, tables, cooking grills or other associated materials will be permitted before or after each event. Violation of this provision will result in a revocation of this Permit.
- _____ 3. For Hukilau Campgrounds use, activities and set-up will be limited to the campgrounds in order to allow access and use of the southern (Hauula) portion of Hukilau Beach area by the public.
- _____ 4. User must have this permit when accessing the Property. There will be no assignment of this Permit to anyone or any other group, or sharing of the Property with anyone or any group without prior written consent of Hawaii Reserves, Inc. (hereafter "HRI").
- _____ 5. User will deliver a deposit of **\$100.00** by personal check to HRI prior to the event. **User is responsible for the cleanup of the area during and after the activity and is to remove and dispose of all trash off-site of Property.** User will be responsible for damages done to the grounds and/or facilities and agrees to reimburse HRI for any and all damages. HRI will inspect the Property after each use. Failure to comply with the provisions of the Permit may result in the forfeiture of the security deposit. Deposit check will be shredded after an approved checkout is

completed by an authorized HRI representative.

6. CHECK IN: Check in at the site can begin at 2pm on Monday, or 8am Tuesday - Friday, no exceptions.

7. CHECK OUT: Check out must be by 6pm - no exceptions. User is to leave the area / Property in the condition that it was found. User is required to remove all trash, tents, and other equipment and vehicles by check-out time. Failure to do so many result in the forfeiture of the User's deposit. User will be responsible for any damages to the grounds and facilities and agrees to pay HRI for reimbursement of damages.

8. For Hukilau Beach use and occupancy, parking or driving of vehicles on grassy areas is prohibited. Parking is strictly limited to within designated parking areas. User will reserve ten (10) parking spaces in the immediately adjacent parking area for use by the public and others not participating in the User's event. HRI reserves the right to revoke this Permit and enforce these conditions as necessary.

9. **The following are prohibited: smoking, illegal drugs, alcoholic beverages, pets/animals, removal of sand, cutting of trees, bon fires, and fundraising or commercial activities of any kind. Enclosed** cooking fires are allowed.

10. User acknowledges that the Property and the adjoining property, beach and ocean may be dangerous. User will exercise caution and extreme care to make sure that any activities conducted are safe for User, guests and others on the Property.

11. While on the Property, User and User's group agree to maintain law and order, including the securing of any and all permits or licenses required by law, and to abide by any other rules set forth by HRI. User and User's group must also obey all traffic and speed limit laws while traveling to and from the Property (along Po'ohaili Street and other streets and roads). Issuance of this permit does not imply that HRI, has knowledge of, or approves of events on site that may take place.

12. User will be considerate of residents, campers and members of the general public in and around the Property, by keeping noise and other impacts in the area to a minimum.

13. Violation of any terms of this Agreement may result in immediate revocation of this Permit, result in the forfeiture of User's deposit, and may jeopardize future use of this Property.

14. Applicant / User signing below affirms that he or she has authority to represent and legally bind all Users and the organizations or groups represented, including for purposes of the attached General Release & Indemnity Agreement.
