#### *PROCEDURE & RULES*

- \_\_\_\_\_ 1. Applicants must be 21 years of age or older.
- \_\_\_\_\_ 2. This Permit application is not transferable. User is not authorized to allow others, unrelated or not associated with user or user group, access to campgrounds. User is not part of a paid or commercial tour/group.
- \_\_\_\_\_ 3. Hukilau and Po'ohaili deposit fees are \$100.00 per reservation and payable by check only.
- \_\_\_\_\_ 4. CHECK IN: Check in at the campsite can begin at 2pm on Monday or 8am on Tuesday-Friday.
- \_\_\_\_\_ 5. CHECK OUT: Check out must be by 6pm on the last day scheduled. User is to leave the camp area in the condition that it was found and must remove all trash, tents, equipment and vehicles off-site from the camp area by check-out time. Failure to do so will result in forfeiture of User's deposit. User will be responsible for any damage to the grounds and facilities and agrees to pay HRI for reimbursement of damages.
- \_\_\_\_\_ 6. Deposit check will be shredded after an approved checkout is completed by an authorized HRI representative.
- \_\_\_\_\_ 7. Camping is permitted in designated areas only.
- \_\_\_\_\_ 8. If camping period is longer than twenty-four hours, User will provide one (1) portable toilet for every thirty (30) campers. Toilets must be cleaned every three (3) days.
- \_\_\_\_\_ 9. **The following are prohibited: Sunday camping or other activities, smoking, drugs, alcoholic beverages, pets/animals, removal of sand, cutting of trees, bon fires, imu or umu fires/pits, and fundraising or commercial activities of any kind. Enclosed cooking fires are allowed.**

- \_\_\_\_\_ 10. User acknowledges that the campgrounds Property and the adjoining property, beach, and ocean may be dangerous. User will exercise caution and extreme care to make sure that any activities conducted are safe for user, guests and others on the Property. User will be considerate of residents, campers, and community members in and around the Property. While on the Property, User and User's group agree to maintain law and order, to keep noise to a minimum after 10:00 pm, and to abide by all applicable laws and any other rules set forth by HRI. User and User's group must obey all traffic and speed limit laws while traveling to and from the campsite (on Kamehameha Hwy, along Po'ohaili Street, and other streets and roads).
- \_\_\_\_\_ 11. Violation of any terms of this agreement will result in the forfeiture of this permit and your deposit, and may jeopardize your future use of the Property.

**GENERAL RELEASE AND INDEMNITY AGREEMENT**

1. We recognize that there is a risk of injury relating to our visit to the area; we agree that we are participating voluntarily. Property Reserve, Inc., and Hawaii Reserves, Inc., and its principals, directors, officers, employees, agents, representatives and related entities (hereinafter collectively referred to as "HRI"), have made no warranty or representation, express or implied, regarding the conditions that may be encountered during our visit.

In exchange for the right to use the area, WE HEREBY AGREE TO RELEASE HRI FROM ANY LIABILITY FOR ANY INCIDENT OR ACCIDENT that may occur, which may result in injury, death, or other damage to others or us. WE ALSO AGREE THAT THIS ALSO APPLIES TO ANYONE ELSE WHO MAY HAVE A RIGHT TO SUE ON OUR BEHALF IF WE GET HURT.
3. WE FURTHER AGREE TO INDEMNIFY AND HOLD HRI HARMLESS from any loss, liability, damage, claim, judgment, demand or expense, including attorney's fees and costs, which may incur because of us. WE UNDERSTAND THIS MEANS THAT WE MUST REIMBURSE HRI FOR ANY SUMS OF MONEY IT MUST SPEND IN ANY ACTION BECAUSE OF US.
